MEETING OUTCOMES

The Harbour Trust invited members of its three advisory groups to participate in an Out of Session meeting to discuss the scope of works for the Stakeholder Engagement and Relationship Review and to provide feedback on the draft document.

Discussion outcomes:

- CAC agreed that the consultant engaged would need to have good experience at working with Government and community with good involvement of the principle of the agency.
- CAC noted that the thrust of the recommendations were right, however some detail could be examined (for example, the need to improve transparency with the Trust Members was supported, but perhaps Trust Member attendance at **all** CAC meetings was not the right mechanism to achieve this).
- CAC agreed it was important that a full range of stakeholders be engaged, not just those knowledgeable about the Harbour Trust. A list of broader stakeholders to be included in the

- scope of work (CAC agreed that it would provide input to the Harbour Trust list, to be circulated post this meeting).
- CAC agreed on the inclusion of a statement of philosophy at the beginning of the scoping document as well as within the objectives & outcomes section that acknowledges the Harbour Trust is committed to engagement and seeking input.
- CAC agreed that scope should include:
 - o Determination of a robust evaluation mechanism
 - Broader engagement with the NSW Government, volunteers and tenants. The methodology of engagement needs to be cost effective
 - o Consideration of use of local government networks and consultative arrangements
 - o Time frame of 6-8 weeks
- Additional comments were provided by the CAC in relation to specific initiatives that would be
 desirable as an outcome of the work including broader opportunities for community
 engagement through wider workshops, small groups forming on specific initiatives and other
 examples of practice used previously by the Harbour Trust.

Mary Darwell advised that the comments would be incorporated in the revised scope of work and invited any further written comments to be provided to the Harbour Trust by COB 17 July.
