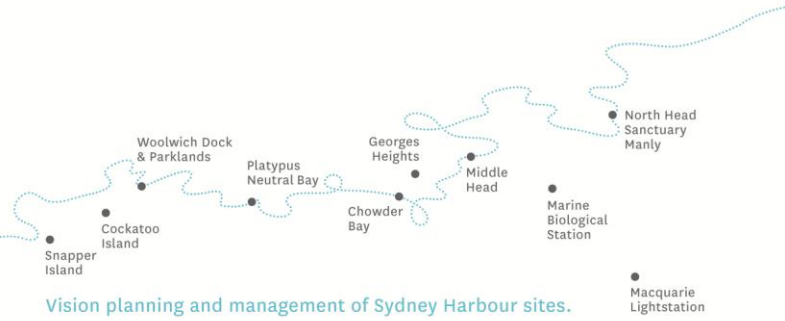

Vehicle Site Induction Pack - Cockatoo Island

Overview

Cockatoo Island (CI) is a pedestrian and cyclist friendly public park and as such vehicle usage on the island is restricted to essential deliveries and services.

With the exception of golf carts, vehicles are not to be used on CI for personal transport.

Prior to barging to CI vehicles require approval from the Sydney Harbour Federation Trust (SHFT) to use CI.

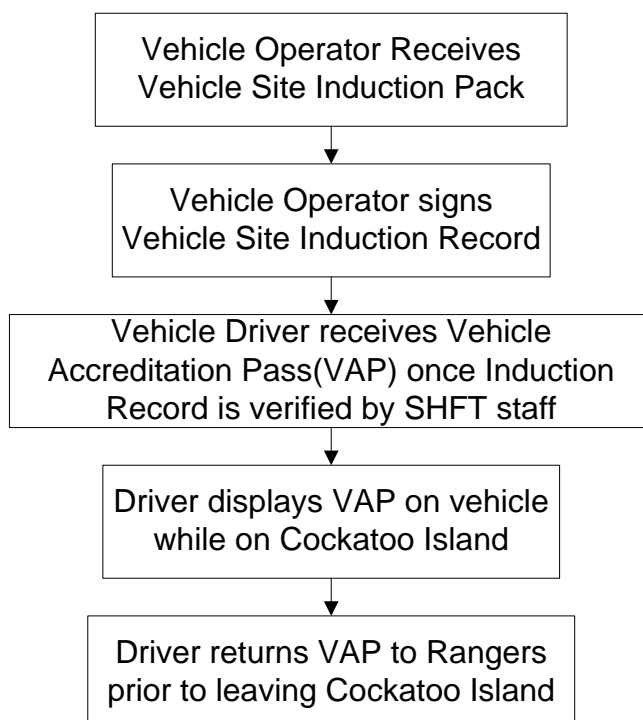
Before operating a vehicle on Cockatoo Island the Operator is required to complete a Vehicle Site Induction.

The induction will make the operator aware of the rules and processes to follow when operating a vehicle on Cockatoo Island.

Process

All vehicle operators who operate vehicles on Cockatoo Island must undergo a Vehicle Site Induction.

Upon arrival at Cockatoo Island, if you have not already been inducted, you must proceed to the Rangers' Office **on foot** to complete your induction process.



Barge Ramp

Please be considerate of local residents when approaching or waiting at the Woolwich barge ramp and ensure noise (i.e. airbrakes and loud conversations) is kept to a minimum.



Cockatoo Island Vehicle Rules

- The speed limit on Cockatoo Island at all times is 10km/h.
- Cockatoo Island is a pedestrian and cyclist friendly public park and as such pedestrians and cyclists have right of way at all times.
- All vehicles, when in motion, are required to have their hazard lights on.
- The vehicle's horn must be sounded before turning blind corners.
- Vehicles may only travel on designated vehicle paths as shown in the attached site map.
- Vehicles are to be used for essential trips only, and not simply for personal transport.
- Passengers may only be carried in designated seats. Passengers are not to be carried in trays, stand on the external area of vehicles or ride on a vehicle not in a designated seat.
- All vehicles operating on Cockatoo Island are required to clearly display a Vehicle Accreditation Permit (VAP).
- If vehicle rules are breached on CI a Sydney Harbour Federation Trust (SHFT) Ranger, Security Guard or Police may issue an infringement notice.
- All NSW road rules should be adhered to while operating a vehicle on CI.
- Parking or driving across footpaths, grassed and landscaped areas is prohibited unless prior arrangements have been made that will protect those surfaces.
- Damage caused must be immediately reported to the Ranger/Security and arrangements made with the SHFT Event Account Manager to protect and repair the damage.
